## TERMS AND CONDITIONS

1. To confirm your reservation you would have to pay a minimum deposit of Rs. 1,000/- for South Indian tours and Rs. 2,000/- for North Indian tours, per participant. The said deposit will be adjusted against the final cost of the tour.
  2. The full payment should reach us 10 days prior (20 days prior for North India tours) to the tour commencement date.
  3. No refund will be made towards unutilised services of the tour.
  4. Advance amount paid towards reservation of seats is not refundable.
  5. Part payment towards tour charges is not refundable.
  6. Cancellation 15 days prior to the onward journey (Excluding the date of journey) 90% of the tour charges (only if paid in full) will be refunded.
  7. Cancellation 5 days prior to the onward journey (Excluding the date of journey) 75% of tour charges (only if paid in full) will be refunded.
  8. No refund of either reservation fees or tour charges will be made if cancellation is made less than 5 days of the onward journey (Excluding the date of journey).
  9. All cancellation must be made in writing. The date on which the written cancellation reaches us will be the date reckoned for date of cancellation.
  10. Return journey tickets will be arranged only if informed before tour departure.
  11. Transportation will be arranged depending on the size of the group.
  12. Tour Timing/Itinerary/Tour-fare are subject to change. Nirmala Travels reserves the right to alter, amend or even cancel any tour depending on the exigencies of the occasion, without assigning any reason. If our tour is cancelled advance amount paid will be refunded in full but no refund of consequential loss will be entertained.
